Purpose of processing personal data

Personal data is processed in order to make arrangements for company events organised for Are's clients and other partners. The processing of personal data is based on the data subject's consent.

Data content in the data file

First name and last name of the data subject who has enrolled for the event is stored in the data file, as well as any contact information and information provided for the event. Event information entered by the data subject may include the following: e-mail address, phone number, street address, date of birth, information about allergies, passport number or social security number.

Regular sources of information

Are's customer and supplier data file and additionally the data subject themselves.

Regular disclosure of data

The data controller may disclose information within the restrictions set and required by current legislation to, among others, partners selected by the data controller for producing a service, unless the data subject has explicitly objected to such disclosure of their data.

In certain situations, we may transfer personal data outside the EU/EEA. In such cases, we ensure data security by transferring information only to countries where the European Commission has concluded that the level of data protection is sufficient or to establishments that have the Commission's standard contractual clauses for the transfer of personal data or other security measures in place, as required by law.

Transfers of data out of EU or EEA

In certain situations, we may transfer personal data outside the EU/EEA. In such cases, we ensure data security by transferring information only to countries where the European Commission has concluded that the level of data protection is sufficient or to establishments that have the Commission's standard contractual clauses for the transfer of personal data or other security measures in place, as required by law.

Data file protection principles

The data security of all manually entered materials and data in the data file has been secured as required by law. Access is provided only to individuals who have been designated by Are and who need the data in their work. They access the data with user IDs and passwords.

The data is located in a closed network that has been secured technically by means of a firewall. Data subjects may review their personal data stored in the system, object to the use of their data or demand the removal or rectification of their data by contacting Are.

Right to review, object and rectify

As regulated in the Personal Data Act, the data subject has the right to review their personal data stored in the data file. Upon request by the data subject, we shall rectify and supplement the data as necessary and erase any information that is erroneous, redundant, insufficient or obsolete for the purpose of the processing. The data can be reviewed and updated by contacting the contact person responsible for matters related to the data file. The request must be made in writing and signed by the data subject.

The data subject has the right to object to the processing and disclosure of their data for direct advertising, remote sales and other direct marketing purposes, and for market surveys and opinion polls, by contacting the contact person for the data file.
